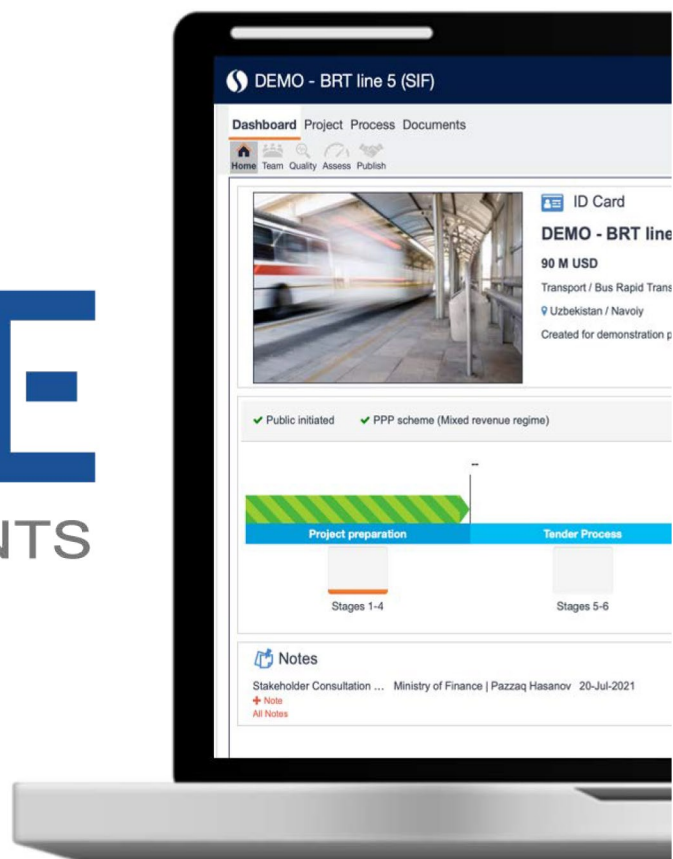

Advancing Quality Infrastructure Investment by Digitalising Project Development

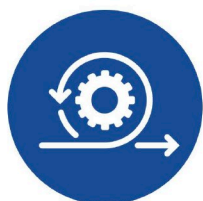

However, significant obstacles to progress are the lack of well developed projects and a projected \$15 trillion infrastructure investment gap by 2040, as indicated by the G20.

Guides well-informed decision making through a structured approach covering the entire project life cycle for PPPs and traditional procurement



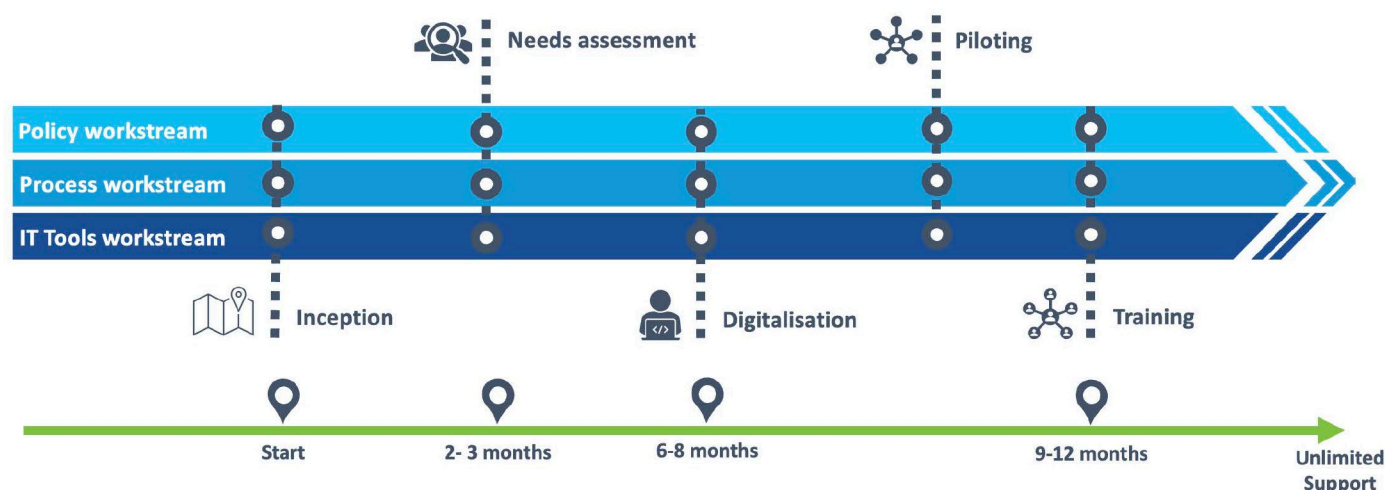
Facilitates multi-stakeholder collaboration and access to international best practices during the development process

Technical assistance enables SOURCE to be fully adaptable to each country's processes, evaluation methodology and and inter-operable with complementary IT systems.

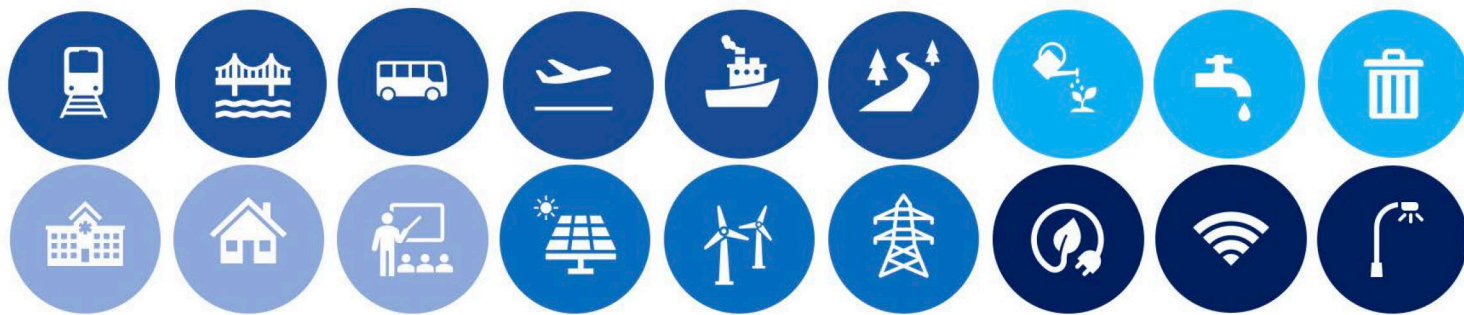
